### Provision of requested information

Thank you for your request for information about Buckingham STW, which we received on 7 February 2025. Your request has been considered under the Environmental Information Regulations 2004.

1. The daily figures for Treated Effluent (TE/ Total Daily Volume (TDV) or Effluent Daily Volume (EDV)) that are derived from the 15 minute records (i.e. 365 or 366 records per calendar year). In other words, the single volumetric figure per day. Could we have those for the last 7 years?

2. Stop/start EDM data from date of installation (April 2022) through to latest available;

4. The daily allowance in M3 for Trade Effluent (TE) to be discharged into the Buckingham network.

The total consented volume from trade effluent to Buckingham catchment is 103.36m<sup>3</sup>/day from 12 consented traders ; the total billing volume from trade in the catchment is 43.03m<sup>3</sup>/day.
